

Meadowfoam is an annual herb belonging to the Limnanthaceae family. Growing up to 0.5 metres high, it has white, cup-shaped flowers and leaves arranged into leaflets.

Meadowfoam Seed Oil is one of the most stable lipids known with naturally occurring tocopherols and the absence of oxidatively susceptible polyunsaturated fatty acids common in other oils.

Limnanthes alba Seed Oil is the oil extracted from the seeds of Limnanthes alba, followed by refining.
