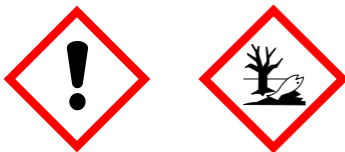

### 4. FIRST AID MEASURES

#### Eye contact

#### Suitable extinguishing media
