## SECTION 4: First aid measures

### 4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. ### If in eyes

### SECTION 7: Handling and storage

#### 7.1. Precautions for safe handling

Prevent formation of gases and vapours in flammable or explosive concentrations and concentrations exceeding the occupational exposure limits. ### 8.2. Exposure controls
