TERMS & CONDITIONS

\$1650 and over ~ 100% freight incentive (Except direct AK or HI, over \$1650, 10% of merchandise amount.)
This incentive is not to exceed the actual freight charges. Invoices must be paid within terms to earn freight incentive. Freight incentives do not apply to collect freight shipments.

FREIGHT CAP Freight capped at 15% of the merchandise total, freight incentives apply. The freight cap will not apply to orders shipped outside the continental US and/or expedited orders (Next Day, 2nd Day, etc).

PAYMENT OPTIONS: Net 30 terms are available with approved credit. Credit limits are based on credit history and/or credit references. Orders processed with approved terms must be paid with a company check (credit cards will not be accepted). Prepayment options include Visa, Mastercard, Discover, American Express, and company check. NO C.O.D orders are accepted.

DELIVERY TERMS The WillowBrook® Company will shop for the least expensive rate. Merchandise will be shipped accordingly unless the Retailer chooses otherwise. The WillowBrook® Company's preferred carriers are: Fedex Ground, USPS and Truckline Carriers.

RETURN POLICY Claims must be made within 10 days after receipt of goods. No return of merchandise will be accepted without a Return Authorization Number assigned by our Customer Service Department. This Return Authorization Number must be printed on the outside of the box. No merchandise with price tickets or store labels will be accepted for return. The WillowBrook® Company is not responsible for shipping charges on any returns. All returns are subject to a 15% restocking fee.

REFUSED SHIPMENTS All refused or undelivered shipments will be subject to a 15% restocking fee.

ACCOUNT STATUS Retailers must place at least one order during each 6 month time period to be considered active. Accounts can be closed at any time at the sole direction of the corporate office, with or without cause.

"This order is subject to approval by the corporate office in South Carolina."
