


The water cooler must be connected to the water supply using a dielectric coupling. The cooler is furnished with a non-metallic strainer which meets this requirement. The drain trap which is provided by the installer should also be plastic to completely isolate the cooler from the building plumbing system.


These products are designed to operate on 20 psi to 105 psi supply line pressure.

C = 1-1/4" Trap (not furnished).

D = Electrical Supply (3) wire recessed box duplex outlet.

E = Insure proper ventilation by maintaining 6" (152mm) (MIN.) clearance from cabinet louvers to wall. F = 7/16" (11mm) Bolt holes for fastening to wall.
