



### Procedures For Warranty Claim:

To make a warranty claim, please contact the original installing dealer before replacing a failed window. Your installing dealer must inspect the failed window and will initiate the warranty claim with Flexfilm. To expedite all warranty claims, original purchasers must have this warranty registration form, the original proof of purchase invoice from the installing dealer, a sample of the failed product, and photos showing the failed product on the vehicle.

### Window Film Care:

Maintenance should be followed to extend the life and appearance of your Flexfilm automotive film, as well as to maintain your warranty coverage. Do not roll down filmed windows for a period of five (5) days until the film has properly adhered to the glass. Do not wash the film for thirty (30) days after installation. Do not use abrasive cleaners or coarse cloths. Use a mild soap and clean, soft cloth or synthetic sponge.

THERE ARE NO OTHER WARRANTIES EITHER EXPRESSED OR IMPLIED. THIS WARRANTY APPLIES ONLY TO MANUFACTURING QUALITY. THE WARRANTY IS NOT VALID WITHOUT ROLL NUMBERS. The installer is solely responsible for the quality of the installation on your vehicle.
