



## Terms and Conditions

### **Agreement between User and www.dixiedecoys.com**

Welcome to www.dixiedecoys.com. The Dixie Decoys® website (the “Site”) is comprised of various web pages operated by Dixie Decoys, LLC (“Dixie Decoys”). www.dixiedecoys.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the “Terms”). Your use of www.dixiedecoys.com constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

www.dixiedecoys.com is an E-Commerce Site, the purpose of which is to advertise, list, and make for sale various waterfowl decoys, apparel, and other products produced and sold by Dixie Decoys.

### **Privacy**

Your use of www.dixiedecoys.com is subject to Dixie Decoy’s Privacy Policy. Please review our Privacy Policy, which also governs the Site and informs users of our data collection practices.

### **Electronic Communications**

Visiting www.dixiedecoys.com or sending emails to Dixie Decoys constitutes electronic communications. You consent to receive electronic communications and you agree that all agreements, notices, disclosures and other communications the we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communications be in writing.

### **Children Under Thirteen**

Dixie Decoys, LLC does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. If you are under 18, you may use www.dixiedecoys.com only with permission of a parent or guardian.

### **Shipping**

Dixie Decoys, LLC is not responsible for delivery issues at the destination. We are responsible, only, for the correct entry of the address provided by the customer into the shipping service’s interface. If a customer provides us with an incorrect address or fails to provide pertinent delivery instructions, we will not be liable for inputting that information into the shipping service’s interface. The customer will be responsible for any cost of re-shipment resulting from an item returned by the delivery service for reasons such as continued failed delivery attempts, incorrect address, or inaccessible delivery location.

### **Import Duties**

The customer shall be responsible for all applicable import duties levied by their respective country. It is the responsibility of the customer, and not Dixie Decoys, LLC, to account for the expected expense of important duties due at the time of product delivery.

### **Cancellation**

Orders may only be cancelled before the item(s) ship. If you wish to cancel your order, please contact Dixie Decoys via telephone number listed in our contact information to expeditiously cancel your order. Any order that has already shipped may not be cancelled.

### **Exchanges**

Exchange requests for items that have been received will only be accepted within (10) calendar days of receipt of your order. Contact us with your order number and a detailed description of the reason for the exchange and what item you would like to replace your received item(s) with. In order to complete an exchange the item must be in original, unused condition with all applicable packaging material intact. Exchanges will not be conducted for items purchased secondhand.

For exchanges that come as a result of the customer’s preference decision, (i.e. wanting a different color/size shirt/hat or different species decoy heads) the customer will be responsible for all shipping costs associated with the exchange. Shipping costs associated with exchanges that come as a result of manufacturer defect or a mistake on the part of Dixie Decoys will be covered by Dixie Decoys. Due to the



varying nature of textile products Dixie Decoys will not be responsible for dissatisfaction with the sizing or coloration of apparel.

### **Returns and Refunds**

If a customer is dissatisfied with the product(s) purchased from Dixie Decoys, they may return said product(s) only after receiving written approval from Dixie Decoys. Certain apparel products sold by Dixie Decoys are produced individually at the time of customer's order. These products are not eligible for return for reasons other than manufacturer defect. They are marked accordingly in the product's description. Contact us at [sales@dixiedecoys.com](mailto:sales@dixiedecoys.com) to submit your return inquiry. Customer will be responsible for all shipping costs except for those cases in which the return comes as a result of manufacturer defect or distribution error by Dixie Decoys. Customer will pay all shipping costs to return the item to Dixie Decoys upfront. Refunds will only be distributed after Dixie Decoys has examined the product to determine whether a manufacturer defect exists or an error was, in fact, committed by Dixie Decoys. Products returned for any reason other than a manufacturer defect or error on the part of Dixie Decoys will be subject to a 25% restocking fee to be deducted from the refund. All returns must be sent via USPS or UPS ground/economy/basic service only. Charges for expedited returns will not be refunded by Dixie Decoys. No returns or exchanges will be accepted on "sale" or "closeout" items.

### **Pricing and Tax**

Product pricing is subject to change without notice. A sales tax of 6.75% will be applied to all orders originating in North Carolina.

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope of enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

### **Class Action Waiver**



Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and Dixie Decoys agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
