Radon Rough-In Requirements for New Buildings in Alberta





What is Radon?

Radon is a naturally-occurring odourless, tasteless and invisible gas created by the radioactive decay of uranium. Alberta's geology creates a greater potential for high radon levels.

Radon is the leading cause of cancer for non-smokers and is responsible for 16 percent of all lung cancer deaths.

New Construction in Alberta Requires Radon Rough-in

In Alberta, radon rough-in details are required in all new commercial and residential buildings with occupancy of four or more hours a day. Rough-in is not the same as an active mitigation system. Rough-in simply ensures the building is designed to improve the efficiency and effectiveness should the occupant decide to put a radon system in.



Commercial New Build Criteria

Alberta Building Code (ABC) 2014 outlines commercial rough-in requirements for buildings used for gatherings of people, care centres, treatment or detention centres, high-hazards industrial occupancies and assembly occupancies (e.g. school, churches) and buildings exceeding 600 m in area or three storeys in height.

Please see the ABC 2014 Division A Section 1.3.3.2 to determine building classifications applicable to Parts 3, 4, 5 and 6.

Residential New Build Criteria

Alberta Building Code (ABC) 2014 has different requirements for residential buildings depending on their size (more or less than 600 m in area) and number of stories (more or less than three storeys).

Please see the ABC 2014 Division A Section 1.3.3.3 to determine building classifications applicable to Parts 9, 10 and 11.
