OFFICIAL RULES

SPONSOR: Utz® Cheese Ball Day 2024 Instagram Sweepstakes (“Sweepstakes”) is sponsored by Utz Quality Foods, LLC (“Sponsor”). Entry information is owned by the Sponsor. The entry information provided will only be used in the event that entrant is selected as a sweepstakes winner or if the entrant has indicated he/she would like to receive additional information from Sponsor.

ELIGIBILITY: NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older as of the date of entry. The Sweepstakes is void where prohibited. Employees of Utz Quality Foods, LLC, their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies (collectively, “Released Parties”), and their immediate and extended family members (including but not limited to spouses, domestic partners, parents, children, and siblings) and household members of each (whether related or not) are not eligible to participate in or win a prize in the Promotion. All federal, state, and local laws and regulations apply. Participation constitutes the entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. PROMOTION PERIOD: The Sweepstakes begins at 12:00 AM Eastern Time (“EST”) on April 17, 2024, and ends at 11:59 PM EST on April 21, 2024 (the “Promotion Period”). The Promotion consists of a Random Draw Sweepstakes (“Sweepstakes”).

HOW TO PARTICIPATE: Visit the Sweepstakes entry page located at www.instagram.com/utzsnacks (“Website”) to submit the required information and complete all entry methods including (1) follow @utzsnacks on Instagram, (2) like the entry post announcing the sweepstakes, (3) comment on the entry post, and (4) agreement to these Official Rules, which will be accessible from the Utz Snacks Instagram page. A total of ten (10) grand prize winners will be randomly selected (as set forth in Section 5: PRIZE). All entries become the property of the Sponsor and will not be acknowledged or returned. False or deceptive entries or acts, as determined by the Sponsor in their sole discretion, will render the entrant ineligible. Participants represent and warrant that they have not purchased any kind of device or internet service in order to submit an entry or participate in and/or enter the Sweepstakes. Collectively, all Website Entries and Mailed Entries will be referred to as (“Entry” or “Entries”).

PRIZE: Sponsor will award ten (10) grand prize winners consisting of:

The prize package is non-refundable and can not be exchanged for cash. A prize winner can not assign or transfer his or her prize to another person. The Approximate Retail Value (“ARV”) of the grand prize is \$89.79. The ARV of all prizes is \$897.90.

WINNER SELECTION: Prize winners will be randomly selected from among all eligible entries received during the Promotion Period. The decisions of the Sponsor will be final and binding and cannot be appealed. Prize winners will be notified by private message, email and/or phone shortly after the drawing on April 22, 2024, and must meet all eligibility requirements.

CLAIMING PRIZES/RELEASE: Eligibility and all claims made by a potential winner are subject to verification. Sponsor is not responsible for fraudulent communications sent to entrants not by Sponsor.
