OFFICIAL RULES

- 1. SPONSOR:** UTZ SNACKING INTO SPRING GIVEAWAY (“Sweepstakes”) is sponsored by Utz Quality Foods, LLC (Sponsors”). Entry information is owned by the Sponsors. The entry information provided will only be used in the event that entrant is selected as a sweepstakes winner or if the entrant has indicated he/she would like to receive additional information from Sponsors. **Sponsors will not provide any entry information to any third-party.**
- 2. ELIGIBILITY:** NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older as of date of entry. The Sweepstakes is void where prohibited. Employees of Utz Quality Foods, LLC, their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies (collectively, “Released Parties”), and their immediate and extended family members (including but not limited to spouses, domestic partners, parents, children, and siblings) and household members of each (whether related or not) are not eligible to participate in or win a prize in the Promotion. All federal, state and local laws and regulations apply. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. - 3. PROMOTION PERIOD:** The Sweepstakes begin at 12:00 PM Eastern Time (“ET”) on March 28th, 2022 and ends at 11:59 PM ET on April 1st, 2022(the “Promotion Period”). The Promotion consists of a Random Draw Sweepstakes (“Sweepstakes”).
- 4. Five (5) Grand Prize winners will be randomly selected (as set forth in Section 5: PRIZE). All entries become the property of Sponsors and will not be acknowledge or returned. False or deceptive entries or acts, as determined by the Sponsors in their sole discretion, will render the entrant ineligible. Participants represent and warrant that they have not purchased any kind of device or internet service in order to submit an entry or participate in and/or enter the Sweepstakes. Collectively, all Website Entries and Mailed Entries will be referred to as (“Entry” or “Entries”).

The decisions of the Sponsors will be final and binding and cannot be appealed. Prize winners will be notified by email and/or phone shortly after the drawing on April 1st 2022 and must meet all eligibility requirements.
7. **CLAIMING PRIZES/RELEASE:** Eligibility and all claims made by a potential winner are subject to verification. Sponsors are not responsible for fraudulent communications sent to entrants not by Sponsors.
