The determined penetration times according to EN 16523-1:2015 are not performed under practical conditions. Therefore a maximum wearing time, which corresponds to 50% of the penetration time, is recommended.

The exact break through time has to be found out by the manufacturer of the protective gloves and has to be observed.

The delayed appearance of symptoms and the development of hypersensitivity (trouble breathing, cough, asthma) are possible. For hypersensitive persons, reactions may be triggered by very low isocyanate concentrations, also below the TLV value.
