

## PRESIDENT'S CORNER

#### What's Next?

The Squash Lake Association is currently going through a transformation. Since its inception, the focus of the SLA has been combatting Eurasian Water Milfoil (EWM). With the exception of monitoring the boat landing and coordinating EWM monitors, that task will now be the role of the Lake District. So what will be the main role of the Squash Lake Association? Well, we have a lot of great options and we're excited about the opportunities. The Lake Management Plan completed in 2014 listed five management goals, of which EWM and invasive species control was just one of the five. The other four include communication and outreach, maintain current water quality conditions, enhance the fishery and monitor the frog population.

We are always looking to improve our communication with homeowners and increase homeowner input and participation. This year we've included postcards with our annual fund raising letter. We are looking to coordinate work shops and seminars on topics that support the Lake Management Plan and that interest homeowners. Please return your postcard or contact us directly regarding seminars or any suggestions on the future role of the Squash Lake Association.

We have been monitoring surface water quality conditions in Squash Lake for years. This year we are teaming up with the UW Extension to offer homeowners economical well testing. Homeowners will get important information regarding the water quality in their wells. In addition, that data may help us to understand groundwater conditions in the Squash Lake watershed. Since surface water and groundwater are interconnected, this information may eventually help us understand the water quality in Squash Lake.

Finally, we've been working with the Sokaogon Chippewa Community to determine the current state of the fishery in Squash Lake. We feel that the Squash Lake Association and homeowners can play an important role in helping to determine why the walleye population has declined and hopefully restore the population in the future.

We feel very optimistic about the future role of the Squash Lake Association. We welcome comments from homeowners and would love to see an increase in homeowner participation. Keep an eye out of for more announcements in the future and feel free to contact me with any questions or concerns.

#### **EWM – Grants by the Numbers**

Often times, the Association gets asked the simplest of questions, "How much have we spent on Eurasian Water Milfoil control?" While a simple question, it is not that easy to answer. First, "how much" is pretty broad. How much in state aid have we received? How much was our volunteer effort worth? How much was spent from the donations we contributed? And, just how much EWM have we removed from the lake over the years? Secondly, most of this information is buried in the grant files over the course of 9 years and not easy to extract.

As we draw closer to the hand-off of EWM control from the Association to the District, it seemed appropriate to summarize these questions, and give you grants by the numbers, excluding data on Clean Boats Clean Waters (boat inspections), Lake Management Planning, and Healthy Lakes. This is for EWM control only as of the close of our harvest season in 2017:

How long have we been receiving aid to combat EWM? 9 years (2009-2017)

How much EWM have we removed from the lake in that time? 27,166 lbs. (13.5 tons)

How much state aid have we received over 9 yrs.? \$151,694.75


How much money came from the Association (unreimbursed) over 9 yrs.? \$46,113.98

How much "in-kind" volunteer value was donated over 9 yrs.? \$40,305.29

(This translates into almost 3,360 hours!) 13.5 tons of EWM...by weight, that's over half a semi trailer full.

## EWM Control Another Successful Year

The divers. Fred Lintereur. Dan Jesse, and Rachel Lintereur, wrapped up our Eurasian Water Milfoil (EWM) diver harvesting season on September 22, 2017. Diving started on June 8<sup>th</sup>, making this the longest diving season we've had in the 8 years of EWM Control on Squash Lake. The divers put in a total of 535 hours in the water, and collected 1585 lbs. of EWM. The efficiencies in diver harvesting we implemented in 2015 and 2016 resulted in a more sparse population of EWM, so fewer pounds needed to be collected in 2017. In addition, we did not need to contract with Many Waters LLC for Diver Assisted Suction Harvesting (DASH). In other words, we made significant headway over the last 3 seasons, while being under budget in 2017. Our consultant, Onterra LLC, is still crunching numbers and reviewing Peak Biomass EWM Survey work done in September, comparing it to the Early Season AIS Survey in June. However, Onterra has indicated that we met our objectives by pushing the density of EWM down by one level of severity across-the-board in all priority locations between June and September, This meets our Lake Management Plan goal of demonstrating control over the invasive species.

Good news does not come without some bad news. First, during the Peak Biomass Survey, Onterra found a new small colony of EWM outside of the bay by the walk-in landing/beach (Opalka Landing), in about 18 ft. of water. This colony is in deeper water and in an area not normally patrolled by our volunteer monitors, being more in the main body of the lake. Our divers were dispatched in mid-September to the area. They recovered 199 lbs. of EWM: 189 lbs. on the first visit, and 10 more lbs. on a follow up visit. This was the single largest daily harvest in any one location all season. Secondly, new single/few plants were discovered at the southern shore of Loon Bay. In 2015 and 2016, a single plant has appeared in the center of the mouth of Loon Bay, and it returned again this year. While the divers have removed it from this location, EWM appears to now have a foothold in the

This situation is typical for all lakes that control EWM. It will diminish in some areas, while cropping up in new areas. If you are interested in seeing where our divers were this year, and how much was collected in various locations, the Association will be posting a map showing this information on our website shortly.




## **CLEAN BOATS/CLEAN WATER**

My Grandpa and Grandma (Ernest & Clara Hahn) bought all 40 acres along the shoreline and the inside area back in the 1940's. I believe it was in 1944. Before that the land and lake was used to move huge logs as there is still a small piece of the "old sawmill" located on the property where the resort boat landing used to be. We have found a ton of horse shoes throughout the

years along the shoreline. My grandparents had 2 children, my dad Gary and then my Aunt Karla. My dad was born in 1938 and he helped my grandparents cut the land and build the cabins. There were 7 cabins in all, but shortly after they were all build, my grandparents sold

I have 3 of them which will go up on some trees on our property once our home is built. The resort cabins were built to only rent out for the summer months. When my parents were going to close the resort in 1994, the county did not want to take over the road. My parents wrote a letter requesting the road be named "Lake Rest Road." # **DNR Changes the Scope of Grant Volunteer/In-Kind Contributions**

In 2017, the DNR expanded what may be counted towards volunteer/in-kind contributions on grant reimbursements. The decision came late in the 2017 season, but will affect grant reimbursement requests in the future. Volunteers, who monitor or remove Eurasian Water Milfoil (EWM) on lakes, including Squash Lake, are now allowed to include donated use of personal equipment. In addition to the \$12/hr of in-kind value for volunteer hours, the use of a motorized boat while performing monitoring or removal of EWM will count for \$10/hr as "in-kind donated use of personal equipment". The use of a row boat, canoe, or kayak (non-motorized boat) will count as \$2.17/hr. All other equipment, such as paddle boards, may not be counted towards in-kind donated use of personal equipment.

All DNR grants require some form of local share from lake organizations. This local share may include a combination of volunteer time, other types of in-kind contributions, and/or shared expenses (monetary share). While our volunteers do an outstanding job in donating their time, it has been impossible to completely match our grant responsibility with only volunteer hours. This is common to all lake organizations across the state. A portion of our obligation has always included sharing in the expenses. This change will help both the Association and the District by shifting the balance in favor of more volunteer/in-kind contributions being counted so less comes from shared expenses.

Volunteer forms for 2018 will be revised to include a line for noting whether a volunteer used a boat, and if so, what type of boat.

As a reminder, all volunteer forms must be signed, dated, and include contact information (either a phone number or email address). The DNR will not accept forms without this information.
