

PABLO & KAT - Privacy Policy

We agree to comply with the legal requirements of the Australian Privacy Principles as set out in the Privacy Act 1988 (CTH) and any other applicable legislation or privacy guidelines. Your privacy is very important to us and we will always act to protect your information in accordance with our Privacy Policy. Our Privacy Policy constitutes part of the Terms and Conditions. Our Privacy Policy outlines the information we may collect about you, our policies on the management of Personal Information and in general what information we hold, for what purposes and how we collect, hold, use and disclose that information.

The information we collect

In order to provide you with services, we may ask for personal details such as your name, address, telephone number or e-mail address. Australian Privacy laws require Pablo & Kat to collect your Personal Information directly from you if it is reasonable and practical to do so. Where we have collected Personal Information about you from another source, Pablo & Kat will take reasonable steps to ensure that you are made aware of:

1. Pablo & Kat collecting Personal Information about you and how you can contact Pablo & Kat regarding the collection of such Personal Information.
2. How you can gain access to the Personal Information collected.
3. Why Pablo & Kat collected the Personal Information.
4. Who Pablo & Kat would usually disclose such Personal Information to any law requiring Pablo & Kat to collect Personal Information and the main consequences (if any) for not providing all or part of the Personal Information.

How that information is used

We do not use or share Personal Information for any purpose other than for the purpose for which it was disclosed. We do not provide or sell Personal Information to other organisations. However we may disclose Personal Information to our service providers who provide services in connection with our products and services.

Keeping information accurate and up to date

We take all reasonable steps to ensure that all Personal Information we hold is as accurate as is possible. You may contact us at any time and ask for its correction if you feel that the Personal Information we have about you is inaccurate or incomplete.

Keeping Information secure

Pablo & Kat takes measures to ensure your Personal Information is protected from unauthorised access, loss, misuse, disclosure or alteration. We store Personal Information in different ways, including in paper and electronic form. We use security procedures and technology to protect the Personal Information we hold. Access to and use of Personal Information within Pablo & Kat is appropriately limited by us to prevent misuse or unlawful disclosure of that Personal Information by others.

Dealing with Pablo & Kat online

We use cookies to enable us to identify you. Most browsers are initially set up to accept cookies. You can reset your browser to refuse all cookies or to warn you before accepting cookies. If you have set your browser to warn you before accepting cookies, you will receive the warning message with each cookie. We use cookies to help us improve our service to visitors to our site and to ensure that our site stays easy to navigate and useful to its visitors.
