Subject to the limitations set forth below, Kendon Industries, LLC warrants every Go! Series™ Stand-Up™ Trailer to be free from defects in workmanship or material for a period of one year from date of purchase. The obligation of Kendon Industries, LLC is limited to repair or replacement (at the sole discretion and option of Kendon Industries, LLC) of parts or products found by Kendon Industries, LLC to be defective, provided buyer has given prompt notice in writing of such defect to Kendon Industries, LLC. The obligation of Kendon Industries, LLC is further conditioned on the right of Kendon Industries, LLC to examine and inspect the part or product to determine that the owner has not made any modifications or alterations to the product after manufacture. It is the owner's responsibility to maintain said products in a condition to allow Kendon Industries, LLC to inspect the product.

All products submitted to Kendon Industries, LLC for evaluation by Kendon Industries, LLC as to whether a warranty claim hereunder will be considered must be shipped to Kendon Industries, LLC with the freight prepaid by the customer. Additionally, all replacement and/or repairing parts are F.O.B. Kendon Industries, LLC 2990 E Miraloma Ave., Anaheim, CA 92806 and the customer shall be responsible for transporting the product back to the customer after warranty service, if any, has been performed.

This warranty shall not apply to any product or parts that have been subject to abuse, misuse, negligence, or accident, or has not been operated in accordance with the instructions of Kendon Industries, LLC. Buyer/owner assumes all risk and liability for the proper use of the product.

Kendon Industries, LLC shall not be liable for incidental, consequential, special, or any other damages of any nature or normal wear and tear. The liability, if any, to buyer/owner or any other person, shall not exceed the amount received by Kendon Industries, LLC from the buyer for the product or parts upon purchase. It is expressly agreed that this warranty shall be in lieu of any other warranty, express or implied. Any warranties of merchantability or fitness for any particular purpose, which has been implied by law, shall be limited to ninety days from the date of purchase. This warranty is not transferable and may be claimed only by the original purchaser of the trailer. This limited warranty becomes null and void in the event that any customer modifications are made to the trailer.

There are no understandings or agreements between Kendon Industries, LLC and the buyer or user concerning the warranty that are not fully expressed herein. No acknowledgements, purchase orders, or other documents, which contain any terms or conditions other than the ones stated herein, shall be binding on Kendon Industries, LLC.

Should any portion of this warranty become void or not enforceable, it shall be severed from the remaining portion of the warranty, which shall remain in force. In the event of any dispute regarding this Limited Warranty between Kendon and the customer or any other party, each party shall bear their own legal costs and fees.
