4.1 Description of first aid measures

After inhalation

No known adverse effects. If fumes or combustion products are inhaled, remove to fresh uncontaminated air, lay patient on back until breathing returns to normal.

After skin contact

May cause an allergic reaction. Remove contaminated clothing. Wash thoroughly with soap and water. Seek medical advice if irritation persists or there is any sign of tissue damage.
