Section 4. First Aid measures

4.1 Description of first aid measures

After inhalation

No known adverse effects. Remove from the exposure area to fresh air, lay patient on back until breathing returns to normal.

After skin contact

Irritating, may cause an allergic reaction. Remove contaminated clothing and wash thoroughly with soap and water. Seek medical advice if irritation persists or there are any signs of tissue damage.

After eye contact
