### 4.1 Description of first aid measures

#### After inhalation

No known adverse effects. If fumes or combustion products are inhaled, remove to fresh uncontaminated air, lay patient on back until breathing returns to normal.

#### After skin contact

Irritating to the skin, may cause an allergic skin reaction. Remove contaminated clothing and wash thoroughly with soap and water. Seek medical advice if irritation persists or there are any signs of tissue damage.
