4.1 Description of first aid measures

After inhalation

If fumes or combustion products are inhaled, remove to fresh uncontaminated air, lay patient on back until breathing returns to normal.

After skin contact

May cause irritation. Remove contaminated clothing and wash thoroughly with soap and water. Seek medical advice if irritation persists or there are any signs of tissue damage.

After eye contact

Causes serious damage to eyes. Flush eyes with plenty of water for 15 minutes including under eyelid. Seek medical advice immediately. Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.
