## Chairmanship

---

### **Sunil Bharti Mittal, Chairman**

Sunil Bharti Mittal became Chairman of ICC on 15 June 2016. Mr Mittal is the Founder and Chairman of Bharti Enterprises, one of India's leading conglomerates with diversified interests in telecom, insurance, real estate, agri and food, besides other ventures. Bharti has joint ventures with several global leaders: Singtel, SoftBank, AXA, and Del Monte, among others. Bharti Airtel, the group's flagship company, is among the world's largest telecommunications companies, offering mobile, fixed broadband and digital TV solutions to over 350 million customers across India, South Asia and Africa. Mr Mittal is a recipient of the Padma Bhushan, one of India's highest civilian honors, awarded to individuals for demonstrating distinguished services of high order.

### **John W.H. Denton AO, First Vice-Chairman**

John Denton became First Vice-Chairman of ICC on 15 June 2016, after serving on the ICC Executive Board. Mr Denton is Chair of the Business Council of Australia's Global Engagement Task Force; Chairman (emeritus) of the Experts Group on Trade and Investment in Indonesia; Board Member of Asialink and Asia Society; and a Founding Member of the Australia-China CEO Roundtable.

## ICC Commissions

---

ICC commissions are specialized working bodies composed of business experts that examine major issues of interest to world business, and prepare policy products including statements to contribute to intergovernmental discussions, and rules and codes to facilitate international business transactions. Commissions can establish task forces for a limited period to carry out specific projects and report back to their parent commission. Task forces may include representatives of more than one commission as a way to address cross-cutting issues more effectively.

The strength and legitimacy of ICC policy statements and rules are derived from the fact that they are developed through extensive consultation with member companies. ICC's normal consultative procedure requires policy documents first to be adopted by one or more commission(s), in consultation with national committees, and then approved by the Executive Board, before they can be regarded as official and public ICC positions.

As a forum for pooling ideas on issues relating to international arbitration and other forms of dispute resolution, the Commission aims to:

- Draft and revise the various ICC rules for dispute resolution.
- Study the juridical and other aspects of arbitration and other modes of international dispute settlement, examine them in view of current developments and produce reports, guidelines or best practices.
- Promote ICC's various dispute resolution services globally.

ATA Carnet is an international customs document that permits the duty-free and tax-free temporary export and import of goods for up to one year. The carnet covers commercial samples, professional equipment, and goods for presentation or use at trade fairs, shows, exhibitions and the like and is valid in 76 countries today.

ICC WCF World ATA Carnet Council (WATAC) is the body that manages the International ATA Carnet Guarantee Chain, which comprises the organizations appointed by their Customs to operate the ATA System around the world.

- Develop an e-ATA Carnet platform for issuing organizations, with links to the World Customs Organization e-ATA project.

### **International Maritime Bureau**

The International Maritime Bureau, established in 1981, was the first operational unit of Commercial Crime Services. It provides members with confidential information on potential trading partners, conducts investigations and monitors ship movements. It has introduced an authentication service for shipping documents presented for payment under documentary credits, thus minimizing the risks of fraud for banks as well as buyers and sellers.

### **Financial and investment fraud**

By stressing crime prevention, the Financial Investigation Bureau has saved companies and individual investors billions of dollars in potential fraud. It draws attention to warning signs that allow investors to take preventative action before funds are committed. CCS provides expertise on security procedures and fast-changing fraudulent techniques.

### **Product counterfeiting**

The Counterfeiting Intelligence Bureau provides a range of services to assist companies in protecting themselves from what is one of the fastest growing economic crimes. These include investigations into the sources and distribution of fake products, identification of websites which enable the marketing and distribution of counterfeit products, consultancy services, intelligence gathering and the provision of expert advice and training.
