

OFFICIAL RULES  
KBIS 2025 Bathroom Vignette Giveaway

**To Enter:**

KBIS Bathroom Vignette Giveaway ("Giveaway") begins on or about February 25, 2025, and ends on February 27, 2025 ("Giveaway Period"). No purchase necessary to enter.

Entry option: Attendees of KBIS who visit the James Martin Vanities (JMV) Booth at KBIS 2025 during the Giveaway Period may enter to win. To enter, an attendee must complete an Entrance Form (via QR code scan) and must select one (1), and may select up to four (4) bathroom vignettes. Participant will be eligible for the drawing for each bathroom vignette selected on the form, however, only one bathroom vignette may be won per participant in the Giveaway.

You understand that by submitting an entry you are: (1) accepting the terms of these Official Rules and agreeing to be bound by them; and (2) you are opting-in to receive e-mail from JMV. All e-mail related to the Giveaway will contain opt-out instructions.

**Eligibility:**

The Giveaway is open only to all KBIS attendees who visit the JMV booth location. The attendee must be at least 21 years old. The prize will be awarded to the registered entered attendee. The following persons are not eligible to enter the Giveaway: (a) employees of James Martin Signature Vanities, LLC or their affiliates, subsidiaries or vendors; (b) immediate family members and persons living in the same household as the persons identified in (a) above. Void where prohibited or restricted by law. Must be a US citizen with US shipping address to enter. Winner must claim prize within 90 days of the drawing.

**Prizes:**

Four (4) winners will be drawn. Each lucky winner will receive one (1) complete bathroom including all furniture, fixtures, and other items included in the Bathroom Vignette on display in the JMV KBIS 2025 Booth. Prizes are the actual items on display in the booth and will be shipped to the winner from the 2025 KBIS location.(Las Vegas, NV). Prizes are "as is" display models and no substitutions are permitted or will be made. Approximate retail value of each Bathroom Vignette between \$16,000 to \$22,000.

The prize may not be transferred, substituted, or exchanged. ALL FEDERAL, STATE AND LOCAL TAXES THAT MAY APPLY FROM THE PRIZE ARE THE SOLE RESPONSIBILITY OF THE PRIZE WINNER. ALL SHIPPING AND HANDLING COSTS ARE THE SOLE RESPONSIBILITY OF THE PRIZE WINNER. ALL PRIZES MUST SHIP WITHIN 30 DAYS OF WINNER(S) BEING NOTIFIED. ALL PRIZES WILL BE AWARDED TO THE LUCKY WINNER. In the event a winner must forfeit for any reason and provided enough notice is provided to allow Sponsor to draw a new winner, forfeited prize will be awarded to new winner. If Sponsor is unable to find a new eligible winner after a second Giveaway, Sponsor is not required to award the forfeited prize. However, Sponsor will attempt to find a new eligible winner. Each participant may only win one (1) prize.

**Winner Notification:**

The prize winner will be selected by random drawing from all eligible entries received for each Bathroom Vignette. Odds of winning will depend upon the number of eligible entries received for each Bathroom Vignette. The winner will be drawn and announced via social media and email on Friday, February 28th. Winner need not be present to win but must acknowledge awarding of prize and accept prize within 14 days of drawing.

The winner will receive a copy of an Affidavit of Eligibility and Publicity Release ("Affidavit and Release"). Within ten (10) days of receipt of the Affidavit and Release, the winner shall be required to sign, notarize and return to JMV the Affidavit and Release. The winner must provide their full legal name, mailing address (do NOT use a PO Box) and social security number or federal ID tax number in the Affidavit and Release. Failure to sign and return the Affidavit and Release within

the time requested may result in forfeiture of the prize. No responsibility is assumed for lost, stolen, late or misdirected mail. The Affidavit and Release is null and void if incomplete, illegible or erroneous.
