B. 2021/22 Service planning, proposed budget Marin Transit Approve

and pass pricing

Chris Whitlock, Marin Transit Operations Analyst, reported that service plan options were developed based on the lottery request survey results and assumed that White Hill has staggered AM start times and one PM release time (bell

schedule still being finalized). Most students prefer PM buses that depart immediately after release time rather than buses that return for second round of students. Historically, RVSD yellow bus has been a six-bus program, but currently appears to be financially infeasible.

Whitlock presented proposal for two 5 bus programs, with most buses serving multiple routes providing more opportunities to sell passes and improve program financials. Five bus programs will also accommodate Hidden Valley route (one bus) as well as the Charter (four buses integrated into White Hill route).

Whitlock reported that Michael's cost per bus per day has increased, but Marin Transit reduced costs of bus tracking and monitoring. Revenues from County, San Anselmo and Measure AA confirmed. Fairfax funding approval in progress. Key variables in scenario development: number of buses, estimated pass sales, pass pricing. Decrease in White Hill enrollment also plays into pricing — 645 students projected for 2021-22.

Fairfax Council Member Renee Goddard asked if "Center and Bridge" bus stop is same as bus stop at the "Hub" in San Anselmo. Whitlock confirmed. Dave Donery asked if Memorial Park stop would still be used to serve students going to Hidden Valley. Whitlock confirmed. County of Marin Supervisor Rice asked if changes to COVID yellow bus guidelines would drive any changes. Marin Transit confirmed wouldn't cause major changes.

Whitlock reported pass sale and enrollment trend takeaways: enrollment and full price pass sales were relatively stable for the first three years of the program, but sales of reduced-price pass significantly decreased year over year correlating to increased reduced pass price.

Marin Transit General Manager Nancy Whelan presented three scenarios for 2021-22 yellow bus program: Scenario 1 with six buses; Scenario 2 with 5 buses, one way pass price increased by \$10 to \$505- and one-way reduced price at \$100 (20% of full price pass); Scenario 3, same as Scenario 2 but with \$425 rate for later PM bus. All scenarios included assumption of 0 pass sales for Hidden Valley and Ross Valley Charter.

San Anselmo Mayor Brian Colbert asked what monitoring included that would now be done by Michael's. Marin Transit responded that Michael's will be able to track drivers and alert parents if buses are late (which has previously been done by Marin Transit). Supervisor Rice asked if Marin Transit had addresses for students qualifying for reduced price pass. Nancy Vernon answered that information was available about number of students but not their addresses. Supervisor Rice asked Superintendent Marci Trahan her thoughts on Scenario 3. Superintendent Trahan reported that White Hill would be implementing an after school tutoring program that could be accommodated by Scenario 3 with discounted late bus.

Whelan presented 2021/22 budget scenarios and scenario comparison. Scenario 1 pass price is \$670 (\$335 income eligible) with immaterial surplus; Scenario 1 pass price is \$505 (\$100 income eligible) with small surplus; Scenario 3 pass price is \$505, \$425 late bus (\$100 income eligible) with immaterial deficit. Budget uncertainties include Hidden Valley and Ross Valley Charter pass sales.

Supervisor Rice asked if size of surplus in Scenario 1 is enough to get pass price close to that of other scenarios. Marin Transit responded that pass price could decrease to \$630 to balance budget. Goddard asked if late bus in scenarios 2 and 3 would be dependable and if we could give parents a time frame that bus would leave. Marin Transit responded that the student wait time would likely be 30-45 minutes depending on traffic. Garrett Toy suggested that assumption be adjusted for Hidden Valley and Charter pass sales to indicate conservative amount sold (50% of past sales). Surplus would then increase to \$20,000 for scenario 1, and roughly \$9,000 for scenario 3.

Colbert thanked Marin Transit for their work and voiced preference for scenario 3 for equity reasons and reduced PM late bus. Goddard voiced approval for scenario 3 but would like to explore sixth bus. All other JEPA members expressed preference for scenario 3. Whitlock clarified that parents would be able to pick the late bus. They will see time and price upon selection. Passes will be awarded on 6/28 and families have seven days to purchase.

Supervisor Rice asked Marin Transit to express thanks to Michael's Transportation. Town Manager Garrett Toy was lauded for his service to Fairfax upon his move to another position in Sonoma County.

No Public Comment.

JEPA voted to adopt Pass Price Scenario 3.

2021/22 Lottery Results



I. Lottery Request Form submission:

- May 24 through June 2, 2021
- Surveyed interest/confidence and gathered data to assess where the demand is
- After submission families received a 2-letter placement code
- 309 families registered (347 students total)

II. Route Development with a preferred route selection survey sent to families:

- June 28 through July 12, 2021 (deadline extended 2 times)
- Routes developed based on selected stops on the lottery request form
- Routes published at <u>www.rossvalleyschoolbus.com</u>
- Survey sent asking families to select top 3 preferred AM and/or PM routes
- 274 families responded (303 students total)

III. Routes Awarded:

- Beginning July 17, 2021
- Routes awarded based on lottery placement code
- Families automatically put on a waitlist if not awarded first route of preference
- Families given 7 days to purchase the awarded passes
- Staff called unresponsive families for the routes with waitlists
- Unsold passes made available to the next family on the lottery placement code list
- Remaining passes made available to non-lottery participants on August 4, 2021

Lottery Challenges and Takeaways



New lottery process prevented the need for families to rush in purchasing passes

Summer roll-out of the lottery impacted participation

 Some families who registered changed their minds about using the service or did not respond to the second survey

 Post-COVID behaviors for families have changed with more students riding bikes, driving or carpooling

Lottery Challenges and Takeaways Continued...



- Results for the second lottery survey show 3 routes* requested more than the others:
 - WH-9 PM (Express Route to San Anselmo Hub): 82 students
 - WH-10 PM (Memorial Park): 63 students
 - WH-15 PM (San Anselmo Hub via Butterfield Rd): 113 students
 - All 3 of the above routes leave White Hill immediately after the bell
- Wait lists for each route:
 - WH-9 PM (Express Route to San Anselmo Hub): 32 students
 - WH-10 PM (Memorial Park): 11 students
 - WH-15 PM (San Anselmo Hub via Butterfield Rd): 63 students

Pass Sales YTD



- Due to COVID and a decrease in White Hill Middle School enrollment, staff estimated an approximate 25% reduction in the number of passes sold
 - Enrollment as of June 2, 2021: 645 students
 - Projected number of one-way passes sold: 650

- 2021/22 YTD Actual: 567 one-way passes distributed for 336 students
 - 2019/20 YTD: 854 one-way passes to 494 students
 - Enrollment as of September 3, 2021: 666 students
 - 34% reduction



Take-away: Most buses serve multiple routes thereby providing more opportunities to sell passes and improve the program financials. This works best in the morning when WHMS has two start times (0 period and 1st period). With the single release time at WHMS in the afternoon buses have to return to the school to pickup the remaining students. During that time students must wait on campus.

Driver and Daily Operations Update



- Michael's Transportation retained 3 of the 6 drivers that previously operated service in Ross Valley.
- 2 new drivers have been trained on the routes and continue to be monitored by their supervisor
- Michael's Transportation now responsible for notifying schools and families with excessive delays or cancellations

Service issues are reported to Marin Transit for monitoring

- 5 bus program
- One-way passes priced at \$505
- Late departing afternoon routes priced at \$425
- Income qualified one-way passes priced at \$100 (20% of full price)
- 567 one-way pass sold YTD (34% reduction from last operating year)
- Contractor expenses increased from \$578 to \$632 per bus per day
- Marin Transit operations oversight and customer service support now reduced by \$38,387 due to elimination of GPS tracking costs

Measure AA Background



- Voters approved in November 2018 to extend the ½ cent transportation sales tax and expenditure plan with the goal of providing funding to Marin County's core transportation needs
- In FY 2019/20, Marin Transit allocated funds directly to five regular home to school (yellow bus) programs in the urbanized area of Marin County
- Allocations are formula-based and consider a program's one-way pass price and the number of one-way passes distributed
- Participating schools certify annually the following eligibility requirements:
 - Reduced passes that provide a minimum of at least a 50% discount to income eligible students
 - Local funding match of at least 20% of the program costs

Measure AA Continued...



- Due to operational impacts resulting from the pandemic, 3 schools did not operate regular yellow bus programs and were unable to meet the eligible requirements in FY 2020/21
- In February 2021, Marin Transit's Board of Directors approved the following:
 - Participating programs will continue to be eligible for funding even if they did not operate in FY 2020/21
 - Due to the suspension and cancellation of yellow bus services in FY 2020/21 unspent funds will be available to all programs for remobilization and other high priority needs
- \$294,112 unspent funds available

Budget Summary



Current status:

- 34% reduction in pass sales from FY 2019/20
 - − Deficit \approx -\$31,736

Incurred expenses:

- Income eligible one-way passes priced at \$100
 - Previously set at \$242.50 each
 - 30 sold currently
 - $-\Delta \approx $5,488$
- Daily rate increase to \$632 per bus
 - FY 2019/20 rate \$578
 - FY 2020/21 rate \$595.34
 - $-\Delta \approx $32,994$

JPA Action Requested



 Authorize request for remobilization funds to support incurred expenses resulting from program suspension and startup:

$$-$32,994 + $5,488 = $38,482$$
