Placing An Order

Placing an order with Sandman Designs, LLC confirms acceptance of these corporate terms and conditions. Orders must be emailed to sales@cleatuscups.com. Order confirmation will be emailed to you once the order has been processed. Please check your order confirmation immediately. There is a non-cancellation policy for custom orders.

Minimums

Custom Cleatus Cups minimums are 48 per artwork style (A minimum of 24 may be ordered with an additional \$50 surcharge). Stock Cleatus Cups minimums are 24 units. Stock cup styles must be ordered in groups of 6 and quantities of 24. (Ex: 4 stock designs, 6 per design = 24 units).

Stock Cleatus coolers minimums are 36 units. Custom Cleatus Coolers minimums are 72 per artwork style.

SlipSip minimums are 25 units.

Packaging

Cleatus Cups are packaged in quantities of 24 in corrugated boxes. Cleatus Coolers are packaged in quantities of 36 in corrugated boxes.

Prices

Prices are shown in U.S. (\$) dollars and subject to change without notice.

Payment

Individual payment for each order shall be in accordance with the corresponding invoice. **Custom orders require a 50% deposit unless other arrangements have been made.** Orders may be paid via credit card or purchase order. Credit cards accepted are Visa or MasterCard. A 1% discount can be applied to pricing above if paid by check within 10 days of the invoice. All orders shall be due Net 30 days from date of invoice for customers with approved credit only (credit may be denied for any legal reason, and some restrictions may apply). A service charge equal to the lesser of 2% per month or the maximum amount permitted by law shall be assessed on each invoice remaining unpaid 30 days after its due date.

Shipping and Distribution

Cleatus Cups are 100% Made in USA. Cleatus Coolers are 100% assembled in USA. Product is F.O.B. Mooresville, NC USA. Title passes from Sandman Designs, LLC to purchaser upon tender of freight to carrier. Orders are shipped via UPS unless otherwise specified. Shipping charges are added to the invoice. Sandman Designs, LLC provides shipping confirmation to all purchasers with valid email addresses.

Lead Time

Cleatus Cup and Cleatus Cooler delivery time is usually 2-4 weeks after artwork approval. Stock products lead times vary. Custom cooler times vary depending on the conditions existing at the time of the order. Order confirmations include an estimated ship date.

Guarantee

Cleatus Cups are guaranteed for 5 years. Sandman Designs, LLC will replace all products, which Sandman Designs, LLC confirms by visual inspection to have defects in material or workmanship. Items damaged due to normal wear and tear (e.g. fading, scratching), improper care, or abuse will not be replaced. Defective cups are to be sent to us directly for replacement. We will only carry the outbound shipping cost. Purchaser recourse limited to replacement as follows: We will replace the mug(s) with a stock design (non-licensed) found on cleatuscups.com.

Cleatus Coolers typically have no guarantee, unless it is determined that there was a defect in material or workmanship of the product. Please contact a sales representative for details.
