Q: I have a life-threatening peanut allergy. Would you recommend that I use your coconut oil?

A: The facility that our coconut oil is bottled in is not a certified peanut free facility. Please consult your healthcare provider or allergist to see if our products are right for you.

Q: Are your products gluten free?

A: Nutiva Brand products are naturally non-gluten, but are not certified gluten-free. Coconut Secret Brand products are certified gluten-free..

Q: Are your hemp products certified gluten free?

A: No, our hemp products are not certified gluten free.

To qualify for gluten free certification, products need to test less than 20 parts per million. We test every lot of our hemp foods and most of the time they are below those limits. Nutiva hemp products have no gluten containing ingredients in them and there are none in the facility either. However, if you have celiac disease, please be extra cautious and look for Certified Gluten Free products as there is still chance of cross-contamination at the farm level. Please consult your healthcare provider or allergist to see if our products are right for you.

Q: I have a tree nut allergy. Would you recommend that I use your products?
